Resolution No. 2015-20 – Appointment of Special Fire Police

Agreement with DeSales University – Crosswalks and Flashing Warning Devices on Landis Mill Road, Preston Lane and Station Avenue

Motion made by Mr. Leonard and seconded by Mr. Benner to approve the Indemnification and Maintenance Agreement with DeSales University for the installation and ongoing maintenance of crosswalks and flashing warning devices on Landis Mill Road, Preston Lane and Station Avenue, with the understanding that the Agreement might require minor modifications as deemed appropriate by the Township Solicitor.

Resolution No. 2015-24 – Application for Flashing Warning Devices on Landis Mill Road, Preston Lane and Station Avenue

Motion made by Mr. Benner and seconded by Mr. DeMatos to adopt Resolution No. 2015-24 authorizing the Township Manager to submit all necessary documentation to PennDOT in order to secure the required approvals for multiple crosswalk flashing warning devices on Landis Mill Road, Preston Lane and Station Avenue, subject to DeSales University entering into an agreement with the Township for the ongoing maintenance of the crosswalks and flashing warning devices.

Request For Payment – James D. Morrissey, Inc. – Certification No. 4

Motion made by Mr. Leonard and seconded by Mr. Benner to authorize payment in the amount of \$243,554.19 to James D. Morrissey, Inc., for work completed on the Station Avenue Roadway Rehabilitation Project.
