Subject: TOA Locust Valley Request to Revise Discharge of Club House Reviewed your request to allow the club house to connect to the proposed pump station and have 3 of the proposed homes to connect to Locust Valley Road sewers via individual grinder pumps. This is a change from the original proposal that was presented to us by TOA when the project was started.

To do this we will have to revise the Act 537 Special Study to show this change. Currently, Section 2 of the Study outlines that the 125 homes will be pumped to Gun Club Road and the Club House would be pumped to Locust Valley Road. Your planning module would have to be revised to reflect this. Currently, there is no mention of the club house since it was to be serviced separately via the grinder pump and using the existing edu's from the old LVCC facilities. This will no longer be the case. We have scheduled the public meeting for the study on 12/18/17. This should be postponed if you want to modify the study to change your design. This will delay the overall approval of the project. Let me know how you want to proceed.

Size of the grease interceptor has not been determined.

Since the project is replacing existing connections there may be no additional sewage flows generated by the project. Developer will need to submit a Township Planning Module documenting projected flows from the project. Developer must also submit an IPP Wastewater Discharge Permit Application to document the cooking facilities that will be included in the building. This is needed to determine the size of the grease interceptor units.

# INFORMATIONAL MEETING

At 6:30 p.m., members of the Municipal Authority and Sewer Treatment Authority met with Oakhurst Drive residents to discuss the installation of gravity and low pressure sewers to the area east of the I-78 bridge. The meeting ended at 7:25 p.m.

## **ENGINEER'S REPORT**

Karl Schreiter, PE, presented Engineer's report dated January 5, 2018.

Mr. Schreiter said he is waiting on the Weyhill Estates bill of sale for the Spring Valley Pumping Station so it can be dedicated to the Township. He said the punch list items are complete except for installing chimney seals. This is being done currently.

Mr. Schreiter said Joe Geib scheduled a meeting on February 20 with the residents affected by the Sunset Drive/Ackerman's Lane sewer project.

Mr. Beil told Mr. Schreiter that the North Branch Interceptor Design project will be postponed until 2019 or 2020. It will then be added to the budget.

On the Oakhurst Road storm sewer project, Mr. Schreiter said that all laterals on Juniper Road will be replaced during construction.

Mr. Schreiter said that two homes in the Cooper Farms subdivision have connected.

Mr. Schreiter said that Industrial Pretreatment Program annual reports are starting to come in from the permittees.

Mr. Schreiter will attend the January 22 Board of Supervisors meeting where they will vote on approving the plan for Brinley Court and Traditions of America subdivisions. Mr. Schreiter said he expects it to be approved.

Mr. Schreiter has three motions for approval at tonight's meeting.

#### SUPERINTENDENT'S REPORT:

Mr. Cope said he met with Toll Brothers at Weyhill Estates about the chimney sealing.

Mr. Cope said he met with Pidcock because Liberty Village chimney sealing needs to be done.

Mr. Cope also met with the Mountain Glen HOA on required repairs. They have agreed to have the Township complete these repairs.

Mr. Cope met with Posh Properties about having their sewer line installed. He said they did a bad job on road restorations. He said inspections have not been done yet but they filled it in. Mr. Cope said if there are issues, they will have to dig it up.

Mr. Cope said there was a demo of the easement machine and they are very impressed with it. They are moving ahead with purchasing it jointly with Toll Brothers.

Mr. Cope said the issues at Camp Elim have been corrected.
