MOTIONS

Release of Funds – Old Saucon Subdivision Certification No. S-1 (Sanitary Sewer Improvements)

DIRECTION/DISCUSSION ITEMS

Resident Request To Lower Speed Limit On Glen Road From 40 mph to 35 mph Mr. Beil explained the Township received several requests to lower the speed limit on Glen Road. He said if the Board members are interested in lowering the speed limit then they should authorize the Township Engineer to do a study to determine if the current 40 mph speed limit is appropriate. He noted the current speed limit was based on an engineering study done in 1994.

Chairman Benner asked if members of the public wished to comment on this issue.

Fred Colosimo of 5450 Glen Road said vehicles speeding on Glen Road pose a serious safety concern. He asked the Board to consider reducing the speed limit to 30 mph. He said he talked to his neighbor who is a police officer about the possibility of getting speed traps on Glen Road.

John Dobos of 5430 Glen Road said speeding cars on Glen Road present a safety concern to students getting on and off school buses. He described two instances where he observed cars blowing by school buses when their red lights were blinking. He was in favor of lowering the speed limit on Glen Road.

Anastasia Sturm of 5430 Glen Road said speeding vehicles are making it increasingly dangerous for people walking on Glen Road. She said she noticed an increase in both the number and speed of vehicles traveling on Glen Road. She spoke in favor of reducing the speed limit on Glen Road, noting there have been numerous speed-related accidents.

After a lengthy discussion, the Board asked the Police Chief to deploy speed awareness monitors on Glen Road and to gather data on the extent of the speeding problem. The Board agreed to revisit this issue at its meeting on December 16, 2019.

Procedure For Evaluating Applicants Seeking Appointment To Township Boards and Commissions

It was the consensus of the Board of Supervisors to refer this matter to the Appointments Review Committee. The Committee will evaluate all applicants and make recommendations to the full Board concerning possible appointments to the various Township boards and commissions.

Board of Supervisors Regular Meeting Schedule For 2020

Mr. Beil reviewed the proposed 2020 regular meeting schedule with the Board. The proposed 2020 meeting schedule calls for the Board to meet on the second and fourth Monday of each month at 6:30 p.m. which follows the same pattern as 2019.

Mr. Spaeth mentioned the possibility of changing meeting nights so Supervisor meetings don't conflict with School Board meetings. After a brief discussion, the Board decided it was not in favor of changing its meeting nights for 2020.

The Board will consider formally approving the proposed 2020 meeting schedule at its Reorganization meeting on January 6, 2020.
