## CALL TO ORDER

## **PUBLIC COMMENT**

Jerry Werkheiser, 6528 Walnut Lane, thanked the Board and Township staff for addressing a safety concern along a section of trail near the Preston Lane underpass at the Township Community Park. He said the Township's efforts to widen the trail and improve visibility by cutting back the bank have made this section of trail safer.

Old Saucon, Phase 2 - Final Plan - Resolution No. 2020-24

Motion made by Mr. Benner and seconded by Mr. Wagner to adopt Resolution No. 2020-24 approving the Phase 2 Final Subdivision Plan for Old Saucon Investment, L.P.

Attorney Dinkelacker said an issue popped up regarding the village commercial portion of the project. He recommended tabling action on this matter so the developer can address this issue. He said the issue can be resolved by removing the village commercial portion of the project from Phase 2 and incorporating it into a new Phase 3.

Attorney Joseph Piperato was present on behalf of Old Saucon Investment, L.P. He was agreeable to the Board tabling this matter.

Mr. Benner withdrew his motion to approve Resolution No. 2020-24 and Mr. Wagner withdrew his second.

Resolution No. 2020-25 – Approval of Petersen Sewage Facilities Planning Module Motion made by Mr. Wagner and seconded by Mr. Benner to adopt Resolution No. 2020-25 approving the Sewage Facilities Planning Module for the Petersen property at 6795 Passer Road in order to allow the installation of a small flow treatment facility for the purpose of treating and disinfecting sanitary sewage on the property, conditioned upon the property owner securing all necessary permits and entering into a System Maintenance Agreement with the Township in a form acceptable to the Township Solicitor.

Motion made by Mr. Benner and seconded by Mr. Wagner to adopt Resolution No. 2020-23 accepting the deed of easement and agreement for access to the water meter pit constructed in connection with the Lanark Commons Project at the northwest corner of Route 309 and Lanark Road.

Request for Payment - Hopewell Park Project - Certification No. 14

Motion made by Mr. Wagner and seconded by Mr. Inglis to authorize payment in the amount of \$155,402.95 to Barwis Construction for work completed on the Hopewell Park Project.

The motion was approved by a vote of 4 to 0.

Request for Payment - Chestnut Hill Road Stormwater & Roadway Improvements Project - Certification No. 3

Motion made by Mr. Inglis and seconded by Mr. Wagner to authorize payment in the amount of \$358,549.79 to Barwis Construction for work completed on Phase 1 of the Chestnut Hill Road Stormwater & Roadway Improvements Project.

The motion was approved by a vote of 4 to 0.

Request for Payment – Water/Sewer Dept. Garage – Certification No. 8 (Contract 1 – Site Work and General Building)

Motion made by Mr. Wagner and seconded by Mr. Inglis to authorize payment in the amount of \$178,798.50 to Ankiewicz Enterprises for work completed on the Water/Sewer Department Garage.

The motion was approved by a vote of 4 to 0.

Exoneration of Township Real Estate Tax Bill #143 – 7001 PA Route 309

Motion made by Mr. Benner and seconded by Mr. Inglis to exonerate the Upper Saucon Township Tax Collector from collecting 2020 Real Estate Tax Bill #143 for the property at 7001 PA Route 309 (Property Identification No. 642450227028-1) pursuant to correspondence dated June 13, 2020 from the Township Tax Collector.

The motion was approved by a vote of 4 to 0.

Consent Agreement with Coopersburg Borough – Coopersburg Streetscape Project Motion made by Mr. Inglis and seconded by Mr. Wagner to approve the Consent Agreement with Coopersburg Borough which would allow the Borough to construct various pedestrian improvements at the intersection of East Fairmount Street and North Main Street as part of the Coopersburg Streetscape Project, and to authorize the appropriate Township officials to execute said Agreement on behalf of the Township.

The motion was approved by a vote of 4 to 0.

## <u>Request for Payment - Chestnut Hill Road Stormwater & Roadway Improvements Project - Certification No. 4</u>

Motion made by Mr. Inglis and seconded by Mr. Benner to authorize payment in the amount of \$14,748.91 to Barwis Construction for work completed on Phase 1 of the Chestnut Hill Road Stormwater and Roadway Improvements Project.

The motion was approved by a vote of 4 to 0.

## Lawn Mowing and Fertilizing Bids

Mr. Beil reviewed the results of the lawn mowing and fertilizing bids. A lengthy discussion ensued regarding the various options and alternatives that were available to the Board in terms of awarding the bids.

# Lawn Mowing at Community Park and Hopewell Park (Base Bid and Alternates 3 and 4)

Motion made by Mr. Benner and seconded by Mr. Wagner to award the 2020 Lawn Mowing Bid, which includes the Base Bid and Alternates 3 and 4, to Searock's Lawn Care for a total bid price of \$54,353.00.

The motion was approved by a vote of 4 to 0.

# Fertilizing and Weed Prevention at Township Parks and Tumblebrook Golf Course (Alternates 1,2,5 and 7)

Motion made by Mr. Inglis and seconded by Mr. Benner to reject the lone bid received for fertilizing and weed prevention at the Township Parks and Tumblebrook Golf Course, and to authorize the Township Manager to rebid this service in an effort to secure more competitive pricing.

The motion was approved by a vote of 4 to 0.

## Lawn Mowing at Tumblebrook Golf Course (Alternate 6)

Motion made by Mr. Inglis and seconded by Mr. Wagner to reject the lone bid received for lawn mowing at the Tumblebrook Golf Course as it is more economical

to have Township employees continue to mow the Golf Course for the remainder of the 2020 growing season.

The motion was approved by a vote of 4 to 0.
