[Note: \$250,000 was budgeted for the New Restroom Building and Pedestrian Plaza Project at Hopewell Park. Based on the bids received, the Project would cost \$439,115 to construct, or \$189,115 more than the budgeted amount. Consideration should be given to rejecting all bids and authorizing the Township Manager to re-bid the Project early next year.]
