Proposed Ordinance No. 141-R amends the Township Zoning Ordinance to revise regulations relating to forestry uses by eliminating the mandatory participation in a forest stewardship plan as required by Section 517.B.1.C and substituting therefore a recommendation for voluntary participation in, and submission of, a forestry stewardship plan; and further by eliminating mandatory "no timber harvesting buffer zones" as required by Section 517.D.1.J and substituting therefore a requirement of compliance with an approved E&S Plan as well as all permits issued in accordance with applicable law, while encouraging adherence to certain setbacks.
