CALL TO ORDER

RECOGNITION OF DANE CARROLL AND PATRICK LEONARD

PUBLIC HEARING ON PROPOSED ORDINANCE NO. 141-R – FORESTRY USES

Proposed Ordinance No. 141-R amends the Township Zoning Ordinance to revise regulations relating to forestry uses by eliminating the mandatory participation in a forest stewardship plan as required by Section 517.B.1.C and substituting therefore a recommendation for voluntary participation in, and submission of, a forestry stewardship plan; and further by eliminating mandatory "no timber harvesting buffer zones" as required by Section 517.D.1.J and substituting therefore a requirement of compliance with an approved E&S Plan as well as all permits issued in accordance with applicable law, while encouraging adherence to certain setbacks.

Chairman Farrell opened the hearing and asked Solicitor Dinkelacker to handle the proceedings.

Solicitor Dinkelacker summarized proposed Ordinance No. 141-R. He said the proposed Ordinance was prepared in response to a letter dated December 12, 2019 from the State Attorney General's Office.
