The project proposes to connect to the existing sanitary sewer collection system located within the subject parcel.

CORRESPONDENCE COMMENTS:

SOLICITOR'S RÉPORT:

The Solicitor's Report dated January 8, 2021 was presented by Solicitor Brienza.

Solicitor Brienza said that the Yundt easement for the Oakhurst project has been sent to Lehigh County for recording. Once he receives this back it can go out to bid.

Attorney Brienza noted that there was a Mt. Trexler meeting held to discuss acquiring necessary easements. It was determined, due to the scale of the project, that public meetings will need to be held. There are 20-30 easements required, covering a large area. Another meeting with the developer is scheduled for 1/15/2021. A tentative time frame for the public meetings will be late Spring.

ENGINEER'S REPORT:

Andrew Bohl, PE, presented Engineer's report dated January 8, 2021.

Mr. Bohl noted that his report for this meeting should be dated January 8, 2021, not 2020.

Mr. Bohl said that the North Branch interceptor design meeting to update exhibits is to be held 1/15/2021. Surveyors have begun to survey the boundaries and topography.

Mr. Bohl told the Authority that Coopersburg had three exceedance's this month on 12/1/2020, 12/24/20 and 12/25/2020.

Mr. Bohl said that the design documents for Corporate Parkway need to be finalized.

Mr. Bohl noted that the annual IPP questionnaire should go out later this week. He met with Patrick, Ed, and Wendy last week to revamp the annual report. The prior report was very antiquated and seemed to cause confusion as to what exactly was to be submitted. Bruce Bush asked what would be done about the one business that did not submit their IPP and Andy said that repercussions need to be established.

Mr. Bohl indicated that there is a sanitary sewer connection issue in Blue Ridge Estates West. Around Christmas time he received as-builts for Lot 56 and they did not match the design that had been approved. What was approved was the sewer lateral traversing around a proposed storm water underground filtration trench. During construction, the builder decided to go straight through this trench instead of around. Trent Sear flagged it as not matching the approved plans. They are trying to work with the developer and design Engineer to come up with a solution.

Mr. Bohl told the Authority that the developer for Old Saucon is supposed to be fixing the sewer pipe by the OBP pump station that had the sag. Ed Rasich noted that we are getting mud into the pump station due to this construction.

Mr. Bohl said that the Estates at Saucon Valley sewer will connect via Flint Hill Road. This will be an additional 102 homes connecting to our system.

SUPERINTENDENT'S REPORT:

Mr. Lambert told the Authority that in Old Saucon there are three occupied homes to date. They have COB (City of Bethlehem) water but are connected to our sewer. COB is already billing them for their water usage, but we are not billing for sewer usage. The Township Finance Department told us they do not begin billing until they have a CO in hand. At this point they do not have a CO and its unclear when one will be issued.

Mr. Lambert noted that Sewer Department went out to investigate a resident complain about repeated sewer back-ups. They TV'd the nearby lines and found a few area's where there are roots in the sewer main. They removed the roots along with a large grease ball that was tangled up with the roots, so they are going to see if there is better flow during the next storm. This is the same resident who had a check valve but had a bathroom installed in his basement and the plumber that did the work removed the check valve.

Mr. Lambert said that the Sewer Department has been doing stream bank improvements behind Copperhead. The weather has kept them from progressing with the project to put stone in and shore up the stream bank and manholes. They are looking into which option would be better, hardening the entire stream bank in that area or relocating the sewer line.

Mr. Lambert stated that the Department is still working to install new sewer meters so they will all be on-line so flow can be tracked better.

Mr. Lambert told the Authority that most issues in the south branch have been addressed but after looking at the data from several recent storms believes there may be issues that need to be identified in the north branch.

Mr. Lambert also mentioned that the Promenade has had a significant amount of grease recently. They have been notified and are trying to figure out which building the grease is coming from. The Promenade is the only business on that section of line, so we know it's coming from somewhere in there.

Mr. Lambert noted that Coopersburg has contributed to almost 40% of our flow during the last few rain events.

Mr. Lambert said that the escrow account for Liberty Village will only be in place until the end of February, so we are going to go out and inspect the manholes before the escrow runs out.
