Review agenda for Zoning Hearing Board meeting on July 6, 2022

This appeal was filed by Wawa, Inc. and involves a request for the placement of additional signage on the property at 6690 Route 309. After a lengthy discussion, the Board determined that the Township Solicitor should appear before the Zoning Hearing Board and represent the Board of Supervisors as an objector in the appeal of Wawa, Inc. (Appeal No. 2022-07).

Preparation of 2023 Township Budget

It was the consensus of the Board to refer this matter to the Administration and Finance Committee.

Request by Lower Saucon Township to join Southern Lehigh Public Library

The Board reviewed a request by Lower Saucon Township to join the Southern Lehigh Public Library. Lower Saucon Township is currently served by the Hellertown Public Library. It was noted that Lower Saucon Township is interested in leaving the Hellertown Public Library in order to join the Southern Lehigh Public Library. Mr. Beil said the Southern Lehigh Library Board of Directors will consider taking action on this request at one of their upcoming meetings. It was the consensus of the Board that Mr. Beil should write a letter to the Southern Lehigh Library Board of Directors encouraging them to vote in favor of Lower Saucon Township's request. Mr. Beil said he would attend the next meeting of the Library Board of Directors to express the Board's position on this issue.
