Proposed Ordinance No. 174 – Open Space Tax

Motion made by Mr. Inglis and seconded by Mr. Spaeth to adopt proposed Ordinance No. 174 imposing an additional 0.10% earned income tax on Township residents to fund the preservation of open space consistent with the referendum question approved at the General Election of November 2, 2021.

Chairman Farrell asked if anyone from the public wished to comment on the proposed Ordinance. There was no response.

The motion was approved by a vote of 4 to 0.
