Acting Chairman Wagner observed there were no members of the public present in the meeting room to offer comments on the proposed Ordinance.

Acting Chairman Wagner noted for the record that this road's name has nothing to do with him whatsoever and he does not live on Wagner Road.

It was noted the Township is looking to invest in a Certificate of Deposit with TD Bank to take advantage of higher interest rates, however, QNB Bank will remain the Township's primary bank.
