Farley Fry, PE, presented the Engineer's Report dated August 3, 2023.

Mr. Fry said Enagua replaced outlets which seemed to have solved the problem with the bulbs. The electrical contractor completed punch list items last week, so Bill Ramage needs to do a site visit and confirm that all items have been addressed before we release funds. ORGANIZED 198 &
